

# PARANORMAL INVESTIGATION AT THE JUDGE'S LODGING

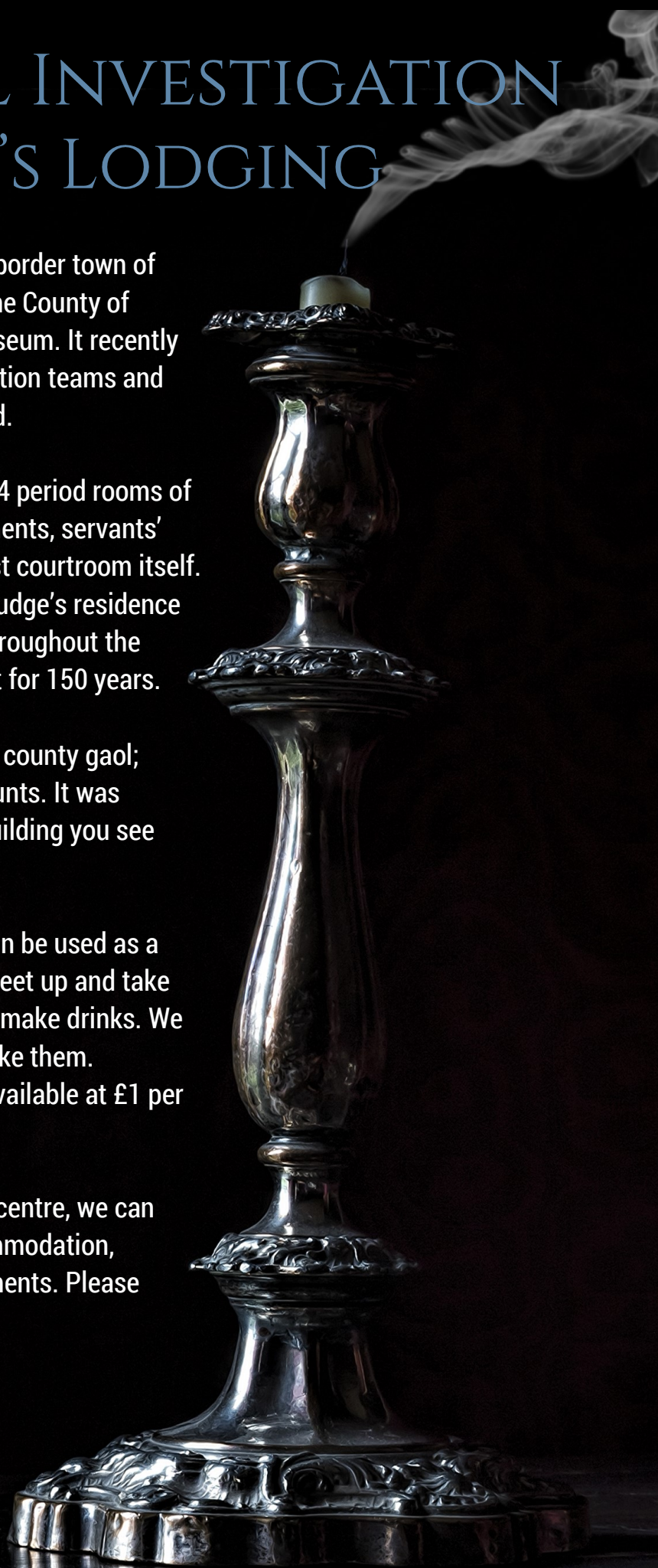
The Judge's Lodging, in the small Welsh border town of Presteigne, is the former Shire Hall for the County of Radnor and is now an award-winning museum. It recently opened its doors to paranormal investigation teams and has been featured twice on Most Haunted.

You will have access to the full suite of 14 period rooms of the building, including the judge's apartments, servants' workrooms, two holding cells and the vast courtroom itself. The building was opened as a court and judge's residence in 1826, seeing cases of all types from throughout the county. It continued to operate as a court for 150 years.

The previous building on the site was the county gaol; a grim affair according to surviving accounts. It was demolished to make way for the grand building you see today.

We have a modern, well lit room which can be used as a 'base', where you can store equipment, meet up and take breaks. There is a kitchen where you can make drinks. We can provide you with cups, if you would like them. Alternatively, there is a drinks machine available at £1 per drink. 3 toilets are also available.

As we run the town's tourist information centre, we can also help you and your guests find accommodation, pre-investigation meals or other requirements. Please just ask.



## CHARGES

The building will be available from 7pm with a get-out time of 2am.

An earlier set-up time is possible at no extra charge.

- For a team of up to 5 leaders and a maximum of 15 guests (20 people total) **£350**
- For a team of up to 5 leaders and a maximum of 30 guests (35 people total) **£450**

If you wish to book for more than 35 people, please contact the Manager to discuss your requirements.

Multiple bookings in one year (3+) will be charged at a loyalty rate of £50 discount per booking.

A deposit of **£100** per date will be required upon booking to secure the date/s you require. This is non-refundable, although it may be possible to change to alternative dates, should they be available. No booking is confirmed until the deposit is received.

A complimentary pre-investigation visit by team leaders during our normal opening hours is most welcome. We will talk to you about your needs and show you the building and its facilities. See our website or call for full opening times.

Once a date is provisionally booked, we will send your contract for you to look over, sign and return to us, along with your deposit. We will also need a copy of your Public Liability insurance. We will then send your booking confirmation.

A note about lighting/electricity: During our daily operation, we are entirely lit by gas and oil lamps. However, these will not run during investigations. We will provide low-level lighting through small table lamps which can be dimmed and battery candles. As there are no additional large lights to put on, we will gladly help you to set up any equipment.
